**ORDER TO PRODUCE RECORDS AND/OR TO DISCLOSE OTHER
PROTECTED HEALTH INFORMATION**

THIS MATTER having come before the Court, the Court having been advised and the parties having stipulated to said order, it is HEREBY ORDERED that the following records shall be produced to the District Attorney's Office. It is further ordered that the District Attorney's Office shall be authorized to issue a subpoena duces tecum to accompany this Court's Order.

IT IS FURTHER ORDERED that once the records are produced to the District Attorney's Office, the District Attorney's Office shall forthwith provide copies of said records to the defendant's counsel.

The Court hereby ORDERS that the following agencies and/or health care facilities and/or their providers shall produce any records in their possession regarding S.L.-R DOB [REDACTED] and V.L.-R DOB [REDACTED] for any treatment received from October 31, 2024, to the present.

The Court hereby further ORDERS that upon request from the State or the defense and receipt of a pretrial interview notice, the following agencies and/or health care facilities shall make treating physicians and other health care providers for S.L.-R DOB [REDACTED] and V.L.-R DOB [REDACTED]; reasonably available for a pre-trial interview regarding any care rendered by the provider to the Patient, as provided in Rule 5-501 and 5-503 of the New Mexico Rules of Criminal Procedure for the District Courts. Physicians and other health care providers requested to give a

pre-trial interview and/or who are called by the State or the defense to testify at the trial in this matter, may discuss and/or testify as to the protected health information of the Patient without the written authorization of the Patient or the Patient's parent or legal guardian for the dates of service that are related to this matter as reflected above.

1) University of New Mexico Hospital - any and all records, including but not limited to: all lab reports, all radiological reports, all nurses' notes and progress notes. This order shall also allow each of the parties to obtain copies of any X-rays, CT Scans, MRIs or other radiologic images.

2) Journey Pediatrics - any and all records, including but not limited to: all lab reports, all radiological reports, all nurses' notes and progress notes. This order shall also allow each of the parties to obtain copies of any X-rays, CT Scans, MRIs or other radiologic images,.

3) All Faiths - any and all records, including but not limited to all progress notes, nurses' notes, treatment plans, medication records, and other treatment records whether hand written or typed.
